NVQ Circular 02/2016

Equivalence of National Diploma in Information and Communication Technology (NDICT) to NVQ Level 5

National Diploma in Information and Communication Technology (NDICT) course was introduced in 2004 under the Skills Development Project and course was conducted in VTA, NAITA and DTET under the purview of Ministry in the subject of Vocational Training. Course duration of NDICT was full time one year. Entry qualification for NDICT was National Certificate in Information and Communication Technology (NCICT) which was a fulltime 6 months course. These two courses were introduced before implementation of the NVQ framework.

After developing National Competency Standards for in Information and Communication Technology Technician(NVQ Level 4)and Information and Communication Technology(NVQ Level 5) the NCICT course was converted to NVQ Level 4 and NDICT to NVQ Level 5.

On request of the VTA to map NDICT qualification to comparable level of NVQ, Director General of the TVEC appointed an expert panel in ICT and NVQ framework.

Since the content of each module is matched with the NVQ level descriptor and comply with the credit requirement for NVQ level 5, committee recommends issuing letter of equivalence to NVQ Level 5 those `who have fulfilled following requirements.

1. Should have NCICT as entry qualification or ICT related NVQ 3 or 4 certificate
2. Successfully completed the NDICT course
3. Minimum of two(2) year experience in ICT related occupation

The Commission approved the above recommendation and issue letter of equivalence to NVQ Level 5 those who have fulfilled the above requirements.
