## Equivalence of National Certificate for Industrial Technicians (NCIT) – Civil programme to NVQ Level 5 in Construction Technology

National Certificate for Industrial Technicians (NCIT) – Civil, is a two year full-time programme with a six months On the Job Training, conducted by the Department of Technical Education & Training (DTET).

On the request of the DTET to map NCIT (Civil) qualification to a compatible level of NVQ, the Governing Council of the Commission at its meeting held on 19-12-2012, approved to equate NCIT programme to NVQ Level 5 based on the recommendations of the Equating & Validation Committee of NAITA and as per the guidelines of the NVQ Circular 5/2011, subject to following conditions.

- NCIT (Civil) certificate holders who seek NVQ compatible level should have obtained pass in following subjects,
  - · Building Construction
  - · Measurement & Specifications
  - · Theory & Design structures
  - · Construction drawings

- · Engineering surveying
- · Water supply & sanitation
- · Highway engineering
- · Irrigation engineering
- II. Since NCIT programme does not cover the Employability Competencies that required for NVQ Level 5, NCIT candidates are expected to provide acceptable evidences on Employability competencies acquired during On-the-Job Training. Adequacy of the evidences of OJT is to be verified at a professional review conducted by a panel of Chartered Civil Engineers
- III. As it is expected to convert NCIT into NVQ programme from 2013, this mapping would be valid for NCIT candidates who enroll and successfully complete the programme in 2012 or before

The NCIT certificate holders who fulfill above three conditions are eligible to be awarded with NVQ Level 5 as the NCIT is equated to NCT (Civil). NCT (Civil) has been mapped with NVQ Level 5 by NVQ Circulars of 3/2011 and 4/2011

Sum of LKR 2000.00 has to be levied as processing fees of professional review from every candidate. In the event of urgent request and if there is no sufficient number of candidates available for review, such candidate has to bear the cost of professional review.
