Invitation for Bids (IFB)

UPGRADING OF 8th FLOOR.

1. The Chairman, Department Procurement Committee on behalf of the Director General, Tertiary and Vocational Education Commission of Sri Lanka invites sealed bids from eligible and qualified bidders for "upgrading of 8th floor". The contract period is 60 days.
2. Bidding will be conducted through National Competitive Bidding Procedure.
3. To be eligible for contract award, the successful bidder shall not have been blacklisted and shall be registered in the field of building construction for Grade C7 or above with the Construction Industry Development Authority (CIDA) valid until the date of awarding of the bids.
4. To be eligible for contract award, the successful bidder shall fulfill following qualification criteria
 - Total turnover of Construction Work completed During the Last 5 Years: Rs.30M Inclusive of minimum of Rs.3M each year
 - Experience in the construction of at least one contract of a nature and complexity equivalent to the Works over the last 5 years shall be 7M
 - The minimum amount of liquid assets and/or credit facilities shall be Rs. 1M

Upon payment of a non-refundable fee of Rupees 2,000.00

Bids shall be delivered or sent by registered post in original and duplicate to the Chairman, Department Procurement Committee, Tertiary and Vocational Education Commission of Sri Lanka, No. 354/2, Elvitigala Mawatha, Colombo 5 to reach on or before 1400hrs on 12.10.2017. Late bids will be rejected. Bids will be opened soon after closing in the presence of the bidders' representatives who choose to attend.

8. Bids shall be valid for a period of 120 days from the last date fixed for receiving of bids or any extended period.

All bids shall be accompanied by a Unconditional on demand bid Security issued by any commercial bank operating in Sri Lanka approved by Central Bank for an amount of Rs. 90,000.00 valid up to 16.03.2018 and shall be in favor of Director General. Tertiary and Vocational Education Commission of Sri Lanka or Rs.45, 000.00 payable to cashier of Tertiary and Vocational Education Commission of Sri Lanka.
