The Tertiary and Vocational Education Commission is the national regulatory body for policy planning, development, standardization and skills certification in the Technical and Vocational Education and Training (TVET) sector.

Vacancies

The Tertiary and Vocational Education Commission (TVEC) invites applications from suitably qualified persons for the following position.

Deputy Director General (One Position)

External applicants

- (I) Bachelors degree in the discipline of Engineering/ Education/ Economics/ Management/ Natural Science obtained from a local or foreign degree awarding institution recognized by the University Grants Commission or an institution established by an Act of Parliament of Sri Lanka.

and

- (II) Postgraduate degree in the discipline relevant to the above field obtained from a local or foreign degree awarding institution recognized by the University Grants Commission or an institution established by an Act of Parliament of Sri Lanka

or

Associate membership in the above mentioned discipline obtained from a chartered institution awarding professional qualifications established by an Act of Parliament.

- (III) Experience

It is required to have 20 years of working experience at managerial level after obtaining the first degree including the working experience of five years at the senior management level in the Tertiary and Vocational Education and Training sector.

Internal applicants

Qualification and Experience

(i) Applicant should have achieved the qualifications as mentioned above for the external applicants

Or

(ii) He/ She should be completed five (05) years satisfactory service at Tertiary and Vocational Education Commission in a senior management service category (HM 1-1) as a Director.

Others (Other qualifications related to the position/ service)

Able to communicate through Sinhala and English languages and be able to use the computer packages namely Word Processing/ Spread Sheet/Power Point and able to communicate through email would be considered as extra qualifications.

Salary

- Rs. 91,645 – 2700x12 – 124,045 (HM 2-1)

According to the Management Service Circular No 02-2006 (I), this salary scale applies from 2020.01.01 onwards.

Salary starts as Rs.72,599 from 2018.01.01 onwards.

Age Limit

Age should be not less than 35 years and not more than 55 years. The upper age limit will not apply to the internal candidates

General information

a. The selected persons should contribute 8% of their salary to the Employees' Provident Fund and the TVEC will contribute 12% of the salary to the Fund. In addition, the TVEC will contribute 3% of the salary to the Employees' Trust Fund.

b. The positions specified above are permanent and shall have a probation period of three (03) years.

c. Applications should be forwarded along with the certified copies of the certificates of applicant

Self prepared applications shall be sent under registered cover to reach the following address on or before 2018.03.28 those who are serving in the state sector should send their applications through the respective Heads of Institutions indicating clearly whether he/she can be released on selection. The position applied for should be clearly indicated in the top left hand corner of the envelope containing

the application. The applications received late and those incomplete and cannot be recognized will be rejected without notice.
