Termination of National Competency Standards and Curricula


The Commission, at its meeting No. 2023/07/282 held on 25.07.2023 approved the termination of National Competency Standards and curricula of NVQ level 1 – 4 qualifications listed in column 1 of the table given below.

The training institutes conducting accredited courses in CBT, EBT and FLM modes and assessment bodies organizing RPL assessments in these NCS are hereby instructed to use NCSs specified in column 2 of the table with effect from 30.07.2023. Assessments can be done for current students and certificates thereof will be issued in terminated NCS listed in column 1 of the table until specified dates mentioned in column 3 of the table. The TVEC, all the providers and RPL assessment bodies shall act as recommended in column 3 of the table in implementing this circular.

Student search facility of the NVQ online system will remain as it is in all NCS listed in column 1 of the table below.
